This form is for a Director/Chief Executive Officer ("CEO") to give notice of his interests in the securities of the Listed Issuer under section 133, 137N or 137Y of the Securities and Futures Act (Cap. 289) (the "SFA"). Following the approval of the dissolution of Irrucorp Pte Ltd, 31,150,051 ordinary shares previously held through Irrucorp (10.94% of Procurri's total outstanding shares), were transferred to six Procurri team members based in the U.S., reducing Irrucorp's direct interest in the Group to 1.00%. The in-specie transfer increased the direct equity interest of Chairman and Global Chief Executive Officer Thomas Sean Murphy to 3.44% from 0.78%. The dissolution was conducted to reduce the administrative processes and tasks associated with the upkeep of Irrucorp.
