Following the approval of the dissolution of Irrucorp Pte Ltd, 31,150,051 ordinary shares previously held through Irrucorp (10.94% of Procurri's total outstanding shares), were transferred to six Procurri team members based in the U.S., reducing Irrucorp's direct interest in the Group to 1.00%. The in-specie transfer increased the direct equity interest of Executive Director Edward Flachbarth to 3.24% from 0.38%. The dissolution was conducted to eliminate the administrative processes and tasks associated with the upkeep of Irrucorp.
